**Voice Your Support Now! New York Bill to Provide for One-Time
Historic Vehicle Registration Fee**

Legislation (A.B. 10698) in the New York Assembly to provide that historical vehicle owners only pay a one-time registration fee of \$100 upon initial registration is creating a buzz in Albany, but it needs your immediate support. Members of the New York Assembly Transportation Committee, where the bill is pending consideration, need to hear from you now. Several legislators have indicated that a strong show of support from the state automotive hobby could tip the balance in the bill's favor.

- The reduced registration fee would be available to owners of historical vehicles owned and operated as an exhibition piece or collector's item and used for club activities, exhibits, tours, parades, occasional transportation and similar uses.
- Under current New York law, a historical motor vehicle is either a vehicle manufactured more than 25 years ago or one which has unique characteristics and which is determined to be of historical, classic or exhibition value.
- The \$100 one-time fee would replace the current annual fee of \$ \$28.75.
